MINUTES OF THE PARISH COUNCIL MEETING HELD AT THE MEMORIAL HALL, CHARLTON ON MONDAY 15 JULY 2024 AT 7.30PM

PRESENT: Councillor Michael Loggin Chairman; Councillors Mark Bracey, Kevin Ridge, Wayne Rule and Matthew Walsh.

In the absence of the Chairman at the start of the meeting, Councillor Wayne Rule took the Chair temporarily.

18/24 Apologies – Councillor Jordon Bolton submitted his apologies because he was at work. Councillor Linda Baker submitted her apologies because a family member was unwell.

<u>Resolved</u> that the apologies from Councillors Linda Baker and Jordan Bolton be approved and the absences authorised.

- **20/24 Minutes** The minutes of the meeting held on 20 May 2024 were taken as read, duly adopted and signed by the Chairman.

24/24 Village Matters

i) Playing Field Association (PFA) – The Chairman reported that a letter had been received from Brackley Athletic Football with a request to reduce the rent and discuss the line marking and grass cutting.

A planning application for the pavilion would be submitted shortly and over £3000 had been raised so far this year for the project. A fundraising wine tasting evening was also being held on 26 July 2024.

Resolved that:

- 2) a site meeting be arranged with the Chairman, Keith Wilks plus Steve Fothergill and Gareth Webb from Brackley Athletic Football Club to discuss the line marking and grass cutting. **Action TG**
- ii) Myers Close Play Area Prior to the meeting, Councillor Jordan Bolton had reported to the Clerk that the Valencia funding was still under way and he was also working on funding from HS2.

Councillor Kevin Ridge reported that local residents were regularly giving verbal abuse to children who were using the play equipment in the Memorial Hall play area. Councillor Ridge would update the Clerk if it continued and then the matter would be referred to Northamptonshire Police.
